Eligibility Requirements:

- 1. Reached the age of 21 prior to the unit election.
- 2. Have 15 days and NIGHTS of camping as a registered leader, including one and only one long-term camp of at least 6 days & 5 nights within the last two years. (Only 5 nights are counted toward the 15 days and nights requirement.)
- 3. Currently registered and serving as a unit leader, assistant unit leader, or unit/district/council committee member. **NOTE:** A unit may nominate one adult per three elected youth or fraction thereof. In addition to the one-third limit, the unit committee may nominate the currently serving unit leader (but not assistant leaders), as long as he or she has served as unit leader for at least the previous twelve months. District/Council committees may nominate more than one adult.

Because the Order of the Arrow is principally a youth organization, unit, district, and council Scouters are not nominated for membership as recognition. Selection into the Order should take place only when the adult's job in Boy Scouting or Varsity Scouting will make the Order more meaningful in the lives of the youth membership. Selection of the adult is based upon the ability of the adult to perform the requisite functions, and not for recognition of service, including current or prior achievement and position. The adult's membership should provide a positive role model for the growth and development of the youth members of the Lodge.
