

This is the highest award a lodge can earn at the section level. After a long morning of training, the Nachos were ready to compete. We had a lot of fun competing in many events like turkey bowling, tricycle jousting, kickball and the OA Poker All Stars Tournament. All afternoon, the conclave was packed with hot orange shirts all over the place, competing and having fun.
