## Our Lodge Totem is <u>a Quail?</u>

Since I have been in the Order of the Arrow, I have been curious as to the origins and history of our Lodge Totem, the California Quail. I recently decided to research the bird and its relationship to Amangi Nacha. The research provided some interesting information that I though I would share with the lodge since it is a widely unknown topic. Enjoy!

On October 24<sup>th</sup>, 1994 The Amangi Nacha Lodge officially adopted our Bi-Laws as a non-profit organization which specified that the totem of the lodge would be the "California Valley Quail" named "Se-Kah-Ke" in Maidu. Thus, to this day we have the Se-Kah-Ke Squawks as our Lodge Newsletter that, when translated, stands for "Quail Squawks". This is an unusual, but fitting name for our publication since our totem is the California Quail.

The name of the bird raised another research topic since I had seen the quail referred to both as the California Valley Quail and just California Quail. It turns out that the official name of our Lodge Totem is simply California Quail. California Valley Quail is a nick-name for our beloved bird that has appeared in many of the lodge patches and all of our lodge standard issue flaps. However, we should be grateful to have the California Quail as our totem because it is the state bird of California and a native bird to the central valley, of which Amangi Nacha fills the largest portion of.

The most frequently asked question about the quail that I have been asked is what in the world that weird thing is that comes out of its head. The answer is that it is called a plume. It is not a bone or piece of skin, but it is a combination of several feathers that form the tear-drop shape. These feathers only are used by the birds to show the specific individuals health for the purpose of attracting mates for reproduction. Also, similar to myself, the bird is a low-lying pudgy creature that stays close to the ground to forage for its food. It usually takes flight if spooked or threatened, but otherwise it is highly sociable.

I hope that you have enjoyed the brief explanation and history behind our beloved Lodge Totem, the California Quail.


